



LOCAL TRAFFIC ALERT

Effective Saturday, Nov 8, 2025



The REVEL Big Bear Half Marathon will be held on Saturday, November 8, 2025. A portion of race proceeds will be donated to the local community. The half marathon begins on Valley of the Falls Dr and finishes on San Bernardino Ave between Dearborn St and Wabash Ave, near Redlands Sports Park.

Traffic and roadways will be affected from 5:30am -10:30am.

Be aware that runners will be on the roadway the morning of the race. Use caution and be alert to help keep everyone safe. Also note that certain roads in your area will be impacted by adjusted traffic patterns during the race. The reverse side of this postcard outlines those adjusted traffic patterns.

Mentone / Redlands


Runners will make their way through town by running west on Highway 38 (Mentone Blvd), north on Opal Ave, and then west on San Bernardino Ave. The race will finish on San Bernardino Ave south of the Redlands Sports Park.

Access across Highway 38 (Mentone Blvd) will be possible, but there will be delays as officers hold traffic for runners. Mentone Blvd will have East and Westbound lanes open for traffic with Crafton Ave as the main road to go North and South. San Bernardino Ave will be entirely closed for the event starting on Friday, November 7th at 8:00am between Webash Ave and Dearborn St, and will reopen at 5:00pm on Saturday, Nov 8th.

Highway 38 from Valley of the Falls Dr to Mentone

Although Highway 38 will remain open along this stretch, all vehicles will be required to wait for a police escort to proceed. CHP will be regulating the flow of traffic using pilot cars, and delays should be expected.

Local Residents of Angelus Oaks and Forest Falls will be able to travel on Hwy 38 via a pilot car. Please wait on Hwy 38 to be directed by CHP and flaggers. *Travel via pilot cars will only be for local residents.
